What is this Product?

Type

This Product is a Luxembourg investment fund, Investment company with variable capital (SICAV) – Specialised Investment Fund (SIF).

Term

The lifespan of this Product is not limited.

Objectives

The investment objective of the Product is to generate superior long term capital appreciation through a portfolio having a diversified risk profile by a combination of investments in compliance with the SIF Law and the CSSF circular 07/309 on the risk diversification requirements applying to SIFs, section 8 "Investment Restrictions" and this Supplement.

For the purposes of AIFM reporting following the AIFM regulation, the predominant investment strategy of the Product will be hedge fund strategy and the sub-strategy will be 100% other hedge fund strategies.

The Product seeks to accomplish this objective by investing, either directly or indirectly, in a diverse range of eligible investments, not restricted in accordance to geographical area or sector. The Product will primarily invest in listed equities of small, medium and large-sized companies; bonds, including, but not limited to, convertible bonds, contingent bonds, high yield bonds, ETN, fixed rate and floating securities, zero-coupon bonds and treasury bonds, with no particular rating, issued by governments, corporations and other national or supranational bodies; open-ended Investment Funds, including ETFs, and Fund of Funds; structured products, guaranteed or not; money market instruments and deposits.

The Product may also invest in closed-ended Investment Funds and Fund of Funds, including, but not limited to Hedge Funds, SICARs, private equity funds, real estate funds and REITS, as well as in unlisted equities, unlisted debt issued by or loans granted to entities. These investments shall not represent more than 50% of the assets of the Product.

The Product may use derivative financial instruments and special techniques for the purpose of hedging against foreign exchange, interest rates and equity markets risks or in order to protect the value of its portfolio against the variation of the mentioned asset classes. Furthermore, the Product may also, use derivative financial instruments and special techniques to achieve its investment objective or invest in derivative financial instruments for investment purposes, including call and put options on securities or financial instruments, forwards, futures, repos, interest rate swaps, total return swaps, and credit default swaps. The Product may buy and/or sell such derivative financial instruments, i.e. the Product may inter alia buy and/or sell options on securities or financial instruments, forwards and futures on securities or financial instruments and buy protection and/or sell protection under credit default swaps in order to acquire a specific exposure. The Product may hold on an ancillary basis cash and cash equivalents.

In accordance with Section "8. Investment restrictions", the Product may (i) enter into short sales and investments and, (ii) lend/borrow securities and (iii) enter into repurchase agreements.

Intended retail investor

The investment in the Product entails an above-average risk and is only appropriate for well-informed investors within the meaning of Article 2 of the SIF Law who are willing to invest on a long-term basis, do not require liquidity in the short-medium term from their investment and who can take the risk to lose their investment.



What are the risks and what could I get in return ?

The summary risk indicator assumes you keep the Product until maturity end of the recommended holding period (6 years).

The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Significant risk(s) for the Product not taken into account in this indicator include the following:

Credit risk and interest rate risk: The Product invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade. An increase in interest rates may cause the value of fixed-income securities held by the Product to decline. Bond prices and yields have an inverse relationship, when the price of a bond falls the yield rises.

Investments into other UCI/UCITS: A Product which invests in other collective investment schemes will not have an active role in the day-to-day management of the collective investment schemes in which it invests. Moreover, a product will generally not have the opportunity to evaluate the specific investments made by any underlying collective investment schemes before they are made. Accordingly, the returns of a product will primarily depend on the performance of these unrelated underlying product managers and could be substantially adversely affected by the unfavourable performance.

Derivative for hedging purpose: The use of derivatives for hedging in a rising market may restrict potential gains.

Risk linked to the holding of contingent convertible bonds (CoCos): Contingent convertible bonds can be automatically convert into shares or be written down if the financial strength of the issuer falls in a certain way. This may result in substantial or total losses of the bond value.

Risk linked to the holding of convertible bonds: Convertible bonds are hybrid securities between debt and equity, which in principle allow holders to convert their interest in bonds into shares of the issuing company at a specified future date. Investment in convertibles will result in greater volatility than bond investments in standard bonds.

What happens if A&G Luxembourg AM, S.A. is unable to pay out ?
