What is this Product ?

Type

This Product is a Luxembourg investment fund, Investment company with variable capital (SICAV) – Specialised Investment Fund (SIF).

Term

The lifespan of this Product is not limited.

Objectives

To generate superior long term capital appreciation through a portfolio having a diversified risk profile by a combination of investments in compliance with the SIF Law and the CSSF circular 07/309 on the risk diversification requirements applying to SIFs, section 8 “Investment Restrictions” and this Supplement. The Product seeks to accomplish this objective by investing, either directly or indirectly, in a diverse range of eligible investments, not restricted in accordance to geographical area or sector.

Income allocation: Accumulation

Intended retail investor

The investment in the Product entails an above-average risk and is only appropriate for well-informed investors within the meaning of Article 2 of the SIF Law who are willing to invest on a long-term basis, do not require liquidity in the short-medium term from their investment and who can take the risk to lose their investment.

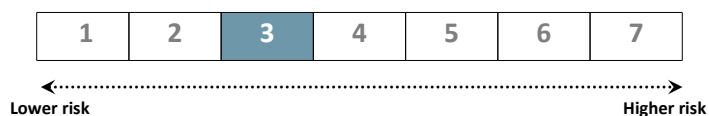

What are the risks and what could I get in return ?

Risk Indicator



The summary risk indicator assumes you keep the Product until maturity end of the recommended holding period (6 years).

The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator), namely:

Risk linked to illiquidity: An investment in a product may carry a general liquidity risk. The Shares may also be affected by restrictions on redemption imposed by the Issue Document under applicable laws. The value of the Shares will fluctuate based upon the performance of the Product, other relevant factors and any third party's assessment thereof. Accordingly, if an Investor transfers or redeems his shares, the sale or redemption price may be lower than the original investment amount.

Credit risk: The issuer of a bond or other debt security (including, but not limited to, governments and their agencies, state and provincial governmental entities, supranationals and companies) may default on their obligations by failing to make payments due, or repay principal and interest in a timely manner which will affect the value of the debt securities held by the portfolio.

Risk of increased costs: By investing in a product which in turn may invest in shares/units issued either by Investment Funds, Funds of Funds or by risk management companies, investors will incur the cost of two or, as the case may be, three form of investment management services.

Risk of Borrowing: The Product may borrow funds for the purpose of a leveraged investment technique, in principle up to 100% of its assets in order to invest. Favourable scenario : this scenario occurred for an investment between 11/2015 and 11/2021.

What happens if A&G Luxembourg AM, S.A. is unable to pay out ?

The Product's ability to pay out would not be affected by the insolvency of the manufacturer. You may however face a financial loss should the Depositary default on its obligations. Such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Product. There is no compensation or guarantee scheme in place which may offset, all or any of, these potential losses.

What are the costs ?

The person advising on or selling this Product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment over time.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario ;
- EUR 10 000 is invested.

How long should I hold it and can I take the money out early ?

Recommended holding period : 6 years

Redemptions are possible on each Valuation Day (each Wednesday) when notified to the Administrative Agent before 12.00 a.m., Luxembourg time, 3 Business Days preceding the Valuation Day; it will take within 30 Business Days for the remit of redemption proceeds.
